## **Important Notice to FPFCU Credit Card Holders**


On April 29, 2024, Financial Partners will be updating our credit card service solution. Here are some things you will need to know about this change:

- Your card <u>account</u> number may change; however, your <u>card</u> number will not change. No new plastics will be issued.
- If you are enrolled in our UChoose rewards program, your enrollment will not change.
- Your access to our credit card service contact center will remain the same and a new Interactive Voice Response (IVR) system will be introduced.
- The online and mobile banking site for your card information will change. However, since it will continue to be single sign on (SSO) access from your e\*Teller account, you will not need to create any new login credentials.
- Your statements will have a new look and feel.

During the update weekend, which will run from April 26 to 28, 2024, access to online credit card information will be unavailable and your limits could be reduced at times.

We appreciate your patience as we implement this improved service.

### 5 tips to prevent card fraud

- 1. Do not click on shopping links found on social media websites. Instead, go directly to the store's website to verify the deal.
- 2. If a merchant reaches out to you regarding personal information, hang up and call that merchant directly with the contact information you have from them.
- 3. Avoid saving data (card numbers and passwords) to mobile devices.
- 4. Avoid using debit cards when online shopping since they are directly linked to your checking account. Rather, use a credit card or pre-loaded card.
- 5. Try out our My FPFCU Cards app where you can monitor activity, set limits, and turn your card on and off.

Below you will find a list of candidates that have been slated by the Nominating Committee and their biographical information.

Pursuant to Article VI, Section 1 of the FPFCU Bylaws:

• ...nominations for vacancies may also be made by petition signed by one percent of the members with a minimum of 20 and a maximum of 500 (at least 40 signatures would be required to comply).

Such petitions must be received by the Chairman of the Board of Financial Partners Federal Credit Union no later than **April 10**, **2024**. Any such nominee shall be required to provide a written statement of qualifications, biographical data and signed certificate that they are agreeable to the nomination and that they will serve if elected to office.
