Just recently, software criminals accessed the MOVEit Transfer Tool used by many financial institutions to hack into the systems, while other criminals are believed to have been responsible for a glitch in a nationwide ATM and ITM network system causing headaches for those affected financial institutions. Thankfully, FPFCU was not a part of this network, and we are running just fine.

I share these things with you not to scare you, but to keep you aware of what is going on in the cyber security world. When you are approached with a "get-rich-quick" scheme, the criminal usually paints a pretty picture, but please do not respond to these phone calls, texts, or letters – they are scams!!!

Rest assured, FPFCU has security measures, policies, and procedures in place to protect our membership data and we continue to review these measures as part of our ongoing commitment to the security of information in our care. If you suspect that you may have been a victim of fraud, we urge you to contact us as soon as possible.

## Being defensive about your personal information and finances

As fraud continues to increase, it is becoming more difficult to know who you can trust.

Scammers are now posing as fraud departments for various merchants sending emails alerting you of fraudulent charges on your account. They also provide contact numbers for so-called "help centers".

If you receive an email, text, or pop-up like this, think twice before you click. If it seems like a familiar business that you have a history with, it is always best to contact that business directly using familiar contact information that you know will put you in touch with the correct business. It is also a good idea not to click on any links listed in an email unless:

- The email was expected and
- You have conducted your own research and feel 100% comfortable

Remember, never give your personal information out without verifying who you are talking to and that they are safe. You are the first defense between fraud and your personal information and finances.
